#### Conservation

Why are conservation efforts needed here in Tonga?

- 1. Protecting, management and long term sustainability of the whales is priority
- 2 Too much competition between boats
- 3. Ensuring the safety of the whales and tourists
- 4. Mnimize/ avoid the collide of bots with whales if skippers behave badly
- 5. Lorenzo Fiori research project in Vava'u,2018



#### Conservation – Actions Taken

- 1. Limiting number of license issued
- 2 Ameximum of 7 hours of watching and swimming activities per day
- 3. No whales activities between the hours of 4pm 5am Mnimize/avoid
- 4. Activities shall only be between the 1<sup>st</sup> of July to 30<sup>th</sup> November of each year.
- 5. All operators to submit of full report at the end of the season including the any data collected for scientific and conservation purposes.



#### **Enforcement Initiatives**

- 1. First ever enforcement of whale activities commenced in 2017 in Vava'u and Tongatapu
- 2. 2018 enforcements were extended to cover all the islands
- 3. We have staff @ 6amin all ports to check the following,
- Vessels
- Skipper & Guides
- Number of passengers
- 4. Sea Patrol once a week with Tonga Police
- 4. All operators to submit weekly reports to the Mnistry
- 5. Vava'u and Tongatapu office have VHF Radio installed in the office
- 6. Purchase of new equipment's for enforcement drone & camera

# Capacity Building for WWS employees

- 1. The Ministry for the first time initiated and hosted the Skipper and Whale Guide Training in 2019.
- 2. Lower the fees to increase level of involvements from locals
- 3. To facilitate and lower the cost to operators and participants, training were carried out not only in the main island of Tongatapu but also in Ha'apai and Vava'u.



4. The Ministry this year capitalize on this COVID-19 Situation with little to no interest on trainings to develop and upgrade our training materials.



# Way Forward

- 1. Finalized and submit new regulations to Cabinet before end of this year.
- 2. To submit a gazette to limit number of whale licence holders
- 3. Launched new skipper and whale guide materials by September
- 4. Look to introduce GIS/ Vessel Monitoring System to all Whale Watch vessel
- 5. Plan a Welcoming of the Whale event OR an Annual Whale event to increase locals awareness of the whales and its importance.
- 6. To work closely with the Ministry of Fisheries and Environment Department to secure a no go zone in the Vava'u water
- 7. Once border is open we will go ahead with out plan to attach to Kaikoura and to meet with NZ Department of Conservation.
- 8. Build a closer working relations with operators through meetings and partner on events and promotions.
