#### INTRODUCTION

This summary offers an initial desk review of Gender and Human Rights Based Approach (HRBA) guidelines and tools pertinent to the design, implementation, monitoring, evaluation, and reporting of biodiversity conservation programs in the Pacific. Consideration has been given to relevant resources specific to the Pacific. The review encompassed various tools and guidelines associated with Gender and HRBA. However, for the sake of clarity and focus on practical application in the Pacific, only the most applicable ones were selected and annotated. These annotations specifically highlight their applicability in mainstreaming Gender and HRBA principles into the field of biodiversity conservation. Many of the reviewed resources emphasize more on gender and social inclusions rather than a human rights-based approach. Notably, there is a scarcity of guidelines pertaining to HRBA in the Pacific, creating a significant gap in the context of biodiversity conservation. The available guides, booklets, and toolkits, however, offer comprehensive guidance on integrating gender-responsive approaches, specifically geared towards mainstreaming gender equality into biodiversity programs.

The target audience to use this document are program and project managers and coordinators. It can be also used by government officers who are looking for resources to support their initiatives in mainstreaming HRBA and GEDSI in relation to resource management and biodiversity conservation.

These resources highlight the significance of various key elements such as conducting thorough gender analysis, developing action plans, and ensuring the meaningful and equitable participation of women and marginalized groups. Additionally, resources stress the importance of making informed decisions in the area of community-based resource management. Noteworthy aspects include addressing diverse needs and rights of different stakeholders involved in biodiversity conservation and management. The overall focus is on fostering a holistic approach that embraces gender equality and social inclusion throughout the entire spectrum of biodiversity initiatives.







#### Gender and Economy in Melanesian Communities: A Manual of Indicators and Tools to Track Change

Summary: The manual is designed to assist researchers, provincial and national governments, and NGO practitioners in monitoring changes in gender relations and the economy in semi-subsistence communities in Melanesian societies in the Pacific. Drawing on primary research about local perspectives on gender equality and economic practices, the manual introduces a set of culturally appropriate indicators designed to gauge community-level transformations.



Furthermore, it provides tools to gather information on (a) indicators of gender equality and the economy for a more extensive understanding of local economies and gender relations, (b) the planning of community-based economic development programs, (c) the comparative analysis of attitudes, behaviors, and economic roles between men and women across various communities, and (d) the assessment of the impact of changing economic and social environments or specific program or policy interventions. In addition to its practical applications, the manual sheds light on the principles of a human rights-based approach, emphasizing gender equality and the equitable treatment of men and women.

It underscores the importance of valuing the contributions of both genders equally, fostering the understanding that collaboration with both women and men is essential for instigating meaningful change and ensuring that both genders reap the benefit of evolving gender relations. While the focus is on Melanesian communities, the principles and tools presented in the manual can be applied to Polynesian and Micronesian communities as well.

Application to the Pacific BioScapes Programme: The manual presents valuable participatory monitoring tools and indicators that can be seamlessly adapted for use into the PBS framework, particularly in activities related to capacity building, sustainable management, and the utilization of coastal and marine natural resources. These tools offer a practical means to evaluate the implementation and impact of programs on gender relations and economic activity within communities associated with PBS initiatives, such as kava cultivation in Fiji and the formulation of guidelines or codes of conduct for tourism interaction in Vanuatu.

Moreover, the human rights-based approach principles outlined in the manual, emphasizing the equal valuation of men and women equally for their work and contributions, hold considerable significance for PBS. These principles align with the overarching goals of PBS, emphasizing the necessity of collaborative efforts with both women and men to create transformative changes in gender relations, ensuring both genders derive benefits from these shifts. While the manual primarily focuses on Melanesian communities, its adaptable tools and principles are equally applicable to Polynesian and Micronesian communities within the PBS scope.

## Women and Men Working Together in Natural Resource Management: A Facilitator's Guide to Gender-Inclusive Natural Resource Management





Summary: The Gender Analysis Guide is designed to guide gender-responsive environmental programming for the International Union for Conservation of Nature (IUCN), its members, partners, and peers. This comprehensive guide encompasses an overview of gender analysis, including IUCN's recommended core domains detailed in Annexes One-Six. Additionally, it provides templates for common actions, such as developing an action plan, with numerous embedded guidance tools and resources. The guide serves as a robust framework for analyzing gender roles, responsibilities, time use, and cultural norms and beliefs. Its aim is to inform rights-based, gender-responsive approaches to environmental policy, programs, and projects. This guideline builds upon IUCN's 2013 Framework for Conducting a Gender Analysis and incorporates insights from previous versions and applications of this tool.



Application to the Pacific BioScapes Programme: The Gender Analysis Guide stands as a resource for the PBS and biodiversity programs in the Pacific, serving to seamlessly integrate gender considerations into conservation and sustainable development endeavor. Notably, it emphasizes the importance of understanding sociocultural structures, norms and power dynamics, encompassing gender, ecosystem services and natural resources. This guide proves particularly beneficial for the PBS can adapt in the initial stages of its activities, aiding in determining the required/requisite information for a comprehensive gender analysis.

Moreover, it provides insights into how the findings from such an analysis might influence activity approaches, strategies, partnerships, indicators, budgets and envisioned outcomes. Various participatory, interactive, and collaborative tools are included in the manual as follows: a) Problem Tree Analysis: to identify root causes and effects of rights issues in forestry, helping participants understand the core problems and their underlying causes and effects; b) Mapping Rights Issues: The manual includes an exercise on mapping rights issues using the bundle of rights framework, which helps in visualizing and analyzing different rights issues related to forest governance; c) Capacity Matrix: to analyze the roles of duty bearers and rights holders, helping to identify capacity gaps and inform capacity development programs for applying a rights-based approach in program/project planning and implementation; d) Power Mapping: used to understand how power relations among institutional stakeholders are crucial for applying a rights-based approach; and e) Action Planning: applying a rights-based approach, which combines concepts and processes explored in previous sessions to design an action plan that applies RBA.

Application to the Pacific BioScapes Programme: This manual is beneficial for the forestry sector, aligning well with PBS activities that involve the assessment of impacts related to kava cultivation on tropical forests, coastal ecosystems and key bird species. The manual is highly relevant given PBS's engagement in developing and implementing solutions for these activities. Its guidance on applying a rights-based approach in forest governance, covering human rights, international standards, tenure regimes, and participatory rights analysis into forestry interventions can enhance the effectiveness of PBS initiatives, ensuring a comprehensive and inclusive approach to addressing forestry-related challenges. The manual serves as a valuable resource for those committed to advancing HRBA within the context of forestry interventions.




