What will the Review + Evaluation + Recommendations + Lessons cover ?

PACC Concept, Strategy and Design

- Project development/ design process
- Problem identification
- Project design, strategy and logic

PACC Project Management arrangements (overall/ regional, national, local)

- Project governance and supervision
- Project resources, staffing, funding (co-resources) and time-frame
- Project “operations” – administration, work planning, reporting
- Project M&E – learning and adaptive management

PACC Project Achievements / implementation ‘performance’

- what has been “delivered” and “achieved” to date, compared to what was planned
- Components 1 + 2 + 3 / regional, national and local
- Inputs → Activities → Results, Outputs, Outcomes → Higher Objectives

3. **Evaluation** of the findings
 - **Relevance + Efficiency + Effectiveness**
 - Sustainability Replicability Scalability
