Republic eo an Marshall Islands (*RMI*) government emoj an erra ilo elon jekjek in kein komadmod (instruments) ko reaurok jen belakin lalin einwot eo ilo 1992 United Nations kwelok eo ikijeen (*Biological Diversity*) men ko rej eddok im mour, 1972 kwelok eo ikijeen aurok eo an ailin ko ewor dren/bat ko ie (*Wetlands of International Importance*) im eo ilo 1992 United Nations (Framework) Monakjen in jerbal eo ikijeen Ukoktak in Mejatoto (*Climate Change*). Ilo Majol in ewor obij ko rej lolorkjake belaak ko emoj aer ejaak, ilo 1984 obij eo an National Environmental Protection Authority, im ilo 1988 Marshall Islands Marine Resources Authority eo.

Kejbarok im lolorkjake men in jerammon ko ej mottan wot wewen mour im manit an armij in Majol jen taujin (*thousands*) iio ko remotlok einwot ilo ejzelok kajitok bwe ej am makitkit im mour rej ekkejil wot ilo men in wonmanlok im ukoktak ko ilo lalin ikijeen ene im lojet. Rainin, ilo lalin jet ian wanjonak ko reaurok ikijeen lojet im men in eddok ko ie jemaron in loi ilo RMI. Ijoke, jet iio ko remotlok, wewen kein emoj aer jino jako lok itok jen an jab jejjit kejerbali ekoba makitkit in jerbal ko retar jen jonaer. JIBADBAD EO AN BOOK IN

The purpose of the Guidebook is to help increase awareness and understanding by the citizens of the Republic of Marshall Islands (RMI) of environmental legislation that has been passed for environmental protection and conservation of natural resources. The Guidebook has been prepared as a user-friendly reference book that summarises the rights, prohibitions and obligations that arise in relation to particular priority areas for environmental protection and natural resources management.

The public is often unaware of the role that they can take in enhancing environmental protection. The Guidebook seeks to increase the public's awareness by summarizing provisions that have direct relevance for the community. However, it does not provide a critique of the adequacy of the legislation that currently applies, nor does it analyse how legislation may be interpreted in any particular situation.

PART ONE introduces the background to environmental protection and conservation of natural resources in RMI and briefly touches on some of the issues that are of most pressing concern.

PART TWO is divided into seven environmental themes critical to RMI. Each theme is introduced and then followed by a framework that identifies any formally acknowledged RIGHTS and what MUST or MUST NOT be done by members of the community.

MAP OF THE REPUBLIC OF MARSHALL ISLANDS



Melele kein make rej kalikar bwe mour an armij ilo RMI elap wot an bedbed ilo jokkin wot juon eo an men in jerammon/ aurok ko ion ene im ilo lojet eo an, im rej kiliar un eo elap ilo jibadbad in nan lolorjake im kejbarok wewen ko renaj kemoururi im kwonmanlok mour an Armij in Majol.

Mantin mour an armij in Majol ej bedbed wot ilo lojet im kein ikkan ko jen taujin iio remotlok; manit eo ar komman bwe kemin mour ilo jokane, im naaj mour maanlok wot kin, men in jerammon ko ibelakim. Ijoke, elon iio remotlok, mantin mour/jerbal im jelalokijken raar jino aer jako lok ilo jet ian aelon ko ilo RMI im, elaptata ijoko elon lok armij ie (urbanized areas), jukjuk im bed ko rej kio bedbed wot ion mona im kein jerbal ko jet jen ilikin jen ko remaron boki jen belaak eo aer. Mene elon wewen ko remman ilo jekjek eo ilo rainin, ekoba bed ilo jikin bok jelalokijken, jikin kenono ko im ad maron tobar lal ko ilikin Majol, emoj an letok kolmenlokijken ibben armij rainin im ekka an kakkure belaak eo (natural environment) nan wanjonak kobij ko rej ilok im rej kakkure lojet eo.

Jej aikuj bukot jet wewen jerbal ko renaj drebij wot jekjek in manit im mour im rej boktok jerammon, botab makitkit in jerbal kein ren jab kajejtokjen im kaban ijo elap kejatdrikdrik kake im ej eddoin lolorjake im kejbarok belaak eo (environmental protection system). Men in jerammon ko jaar mour maantak kaki iumin elon ebeben ko rej aikuj bed ilo kejbarok bwe jen maron emourur im jutak kajur ilo ad jelmae wewen ko rebbin ejjelok melele kaki iliju im jeklaj.

Nan kommane wewen in, jej aikui kejbarok mottan (component parts) ko reaurok ilo belaak eo einwot lojet ak malo eo ad (marine water quality) ekoba ecosystems eo im ej lelok jerbal in kejbarok ak ekka aer ba jerbal in kejbarok eo an lojet eo im belaak eo (ecosystem services). Kim im men ko jabrewot am rainin einwot juon armij ak lol, kim ar tobari einwot menin jolet ko reaurok ko kimij kalimur bwe kim naj onaki im kejbaroki ilo am kaurok ejjelok bar juon men elapllok jen lemoren in am ion ene kein.

Naan kein rej kwalok bwe Kien eo an RMI ewor an eddo nan lolorjake im kejbarok mour im manit eo ad aurok im nan lolorjake jikin likebijnak (home) an armij ro ilo ene ko ilo RMI rainin im iliju. Wewen eo eman tata bwe Kien eo en ketobrake eddo in ej walontak kin jet wewen kakien ak mo ko rebbin (effective) ikijeen kejbarok belaak eo im Droulul ko renaj jerbal lolorjake im kejbarok men in jerammon im men ko bwinnid.

(Legal System) ak ljo ej juraki kakien ko ejjab jemlok an kobatok im letok jiban ilo makitkit ko nan lolorjake kejbarok belaak eo ad. Kakien ak Mo ko (Laws) rej kile im kauteij JMWWE im MARON an armij ro. Rej bareinwot katakin kin wewen ko aikuj lori (KWOJ AIKUJ IN) im jerbal im makitkit ko emoj kamoiki (KWOJ AIKUJ JAB) ak emoj mae ien melim emoj lelok jen Kien eo ak Droulu ko tellokier. Elane melim eo enaj dredrellok jen droulul (agency) eo ej eddoik jerbal eo, enaj ilok ibben emaron ekkejil jet kemelele im wewen (conditions) ko aikuj bokaki ak lori. 3. MEN IN AUROK KO ILO BELAAK EO ILO RMI (ENVIRONMENTAL ISSUES IN THE REPUBLIC)

Jet ian wewen ko reaurok ikijeen belaak eo ad jemaron jela kaki. Jen ien an ien, aban ko ikijeen an **jabwe dren** ilo jikin kejbarok dren ko an Kien im dren ko ibulon bwidej armij rej kejerbali. An etonon melan ko im an ajeded kobij in men in mour ko ebar komman bwe en jelet erro eo an dren eo.

Dren ko ibulon bwidej (**aiboj-lal**) rejjab eman nan kejerbali (**contamination**) im jol (salt) eo emoj an kobalok ibben aeboj eo walok jen an kajur lok walontak in dren eo (**rising sea levels**). Joto-jotak kobij (**Littering**) im jab jejjit kejbarok kobij ko komman jen maal (iron), plastic, bato im ko eirllok wot jej loe kin mejed rainin. Jorren ko jet mottan wot wewen in im jemaron in jab loi ej ilo kein jerbal im manman men in mour im men in eddok ko rekauotata (**Hazardous/toxic waste**) ak **pesticides** im men ko jet einwot **persistent organic pollutant (POPs)**.

Ilo jikin ko elon lok armij ie (urban areas), wewen ko nan drebij erro eo an lojet ej juon men in aikuj eo ejelet elon un ko ikjeen ejmour an armij bareinwot jorren ko rej walok nan men in eddok ko ilo lojet eo itorerein barijet (nearshore ecosystems). Ilo jet jikin ko, erro eo an dren eo itorerein barijet ejjab eman itok jen dren ko retanon rej toor lok jen ion ene (sewage) ekoba kobij an men in mour ko. Jerbal (Development) ko itorerein lojet emoj aer kajededlok lim eo (sedimentation) itok jen an jab jejjit jerbal. Men eo elaptata in, aer kubij tok bok eo ibulon lojet enaj komman an limlim im komman bwe wod ko ren mij lok elane ejjelok jerbal in bobrae. Jerbal kein rej aikuj makitkit kin melim, einwot juon men in aikuj, nan etale im katak kake elane renaj jelet belaak eo. An mij lok men in eddok ko (loss of vegetation) ilo lojet eo (barijet/ion kabbe) ilo juon wewen ekomman bwe en kajurlok walontak in dren, im ebar einwot komman bwe lojet eo en limlim im etonon (siltation and degradation).

Im bar juon, wewen ko jet rej komman an kauotata lojet eo ej ilo an waan enwod im ejerakrok ko ketoorlok oil ko, kobij in dren ko ak dren ko jen em jidrik ko ion wa kein.

Bar juon men ejjab eman jej aikuj lomnak kake ilo RMI ej ilo makitkit ko an armij im rej kakkure aibuijij eo, aurok im jerbal eo an **ecosystems** eo elaptata ion ene, kabbe ko, na ko, itorerein aelon kein. Jorren eo ilo ecosystems eo walok jen land development project ko ej alikar lok itok jen an lonlok armij ilo jikin kein, ekomman bwe en ietlok men in eddok ko (wijken), im remman nan mona im jemaron in bar kalbin ine ko ie, im an jako lok bao mule ko ion Majuro im Wotje. Aolep jorren kein rej walok ilon renaj jelet ecosystems eo im jerbal eman eo an nan jukjuk im bed eo. Bar juon, tar jen jonan enwod itorerein aelon kein ekomman bwe en maatlok ak ietlok ek ko kijed. Ilo malo ko, tar jen jonan enwod ej bar komman bwe en ietlok ak maatlok ek jen makitkit in jerbal ko an waan enwod ko rellap.

Jet ian men in mour ko emoj kalikari bwe emoj an ietlok oraeir (endangered species) ej won (turtles) ko, matmat eo ilojet (sponge), jukkwe (oysters) im ko eirlok wot. Men in mour ko jet (mammels) rej bar bed ilo kejbarok im aolepen belaak eo ilo Majol emoj kamo enwod bako nan kadriklok ietlok in oran bako

4. JORREN KO WALOK JEN UKOKTAK IN MEJATOTO

Ro elap kabel ibbaeir (scientist) rej erra wot ibbendon bwe an kajurlok wewen in ej kakkure (greenhouse gases) mejatoto eo ilo lalin ekomman bwe okmenen eo ilo lalin en lablok jen jonan im makitkit in mejatoto (climate system) eo en oktak lok.

Greenhouse gases ej mejatoto eo etton ak baat ko ewor oaijin, nan wanjonak—jorren in ej walok jen kobij in uno ko rekkajur im ewor mottan pajin ie einwot--carbon dioxide-CO₂; methane (CH₄); nitrous oxide (N₂O); hydrofluorocarbons (HFCs); perfluorocarbons (PFCs); im sulphur hexafluoride (SF₆). Men eo elap kunan nan jorren kein ej **carbon dioxide** eo im ej druojlok jen aer tili kaan ko, elaptata coal, oil, im gas.

Kin wot an kajurlok okmenen eo ilo lalin, makitkit in mejatoto eo emoj an jino oktak lok koto drikdrik ko rej jino erom lan ko rellap (storm) im an mora (drought) belaak otemjjie emoj ad jino kamoli wewen kein ibelakin lalin. Men in elap lok an jelet RMI ilo an tar jen jonan an mora (drought) belaak eo, eo im enaj kolablok aban eo ikijeen dren ko nimed iloan raan kain. Elon lok lan ko rekkajur (severe storm) rej kakkuri torerein ene ko (coastline), melelein bwe makitkit in jerbal ko aikuji nan kokajur lok wewen ko (buffers) rej drebij ak bobrae jiban barijet ko, jet ian wewen kein emoj aer mojno lok itok wot jen an jab jejxit jerbal in bobrae im kejbarok jen ijoko tellokier. (Sea Level) Jonan level in dren eo ilojet ilo RMI ej walon lok kin 3 mm aolep iio otemjjie, eo im ekomman bwe en mokaj lok aer tori im kakkuri torerein ene ko ijoko im makitkit in jerbal ko rejjanin bok jikier nan bobrae. Wewen in ealikar, bunten ko aikuj boki im bojak nan bobrae walontak in dren iliju im jeklaj.

Jorren ko jet walok jen ukoktak in mejatoto ejelet erre eo an belaak eo im kauotata nan lojet eo (ecosystems). Wewen eo kein kajuon, an **kajur lok okmenen (rising ocean temperatures)** eo ilo dren ekauotata nan wod ko ibarijet, ko im elap aer bidodo ak mojno nan mour ilo jonan okmenen eo. Kein karuo, emoj loe bwe ikotaan 30-40% level in carbon dioxide eo ej koba lok (absorbed) ibben malo, river im lake ko im jet ian wewen kein rekomman bwe en lablok an jorren ak nana **(ocean acidity)** dren ko ilo malo eo. Ilo 2010 eo, emoj kar loe bwe 15 iio ko remotlok, jorren in (acidity) ar walon lok kin 6% ilo 100 mita (meters) ijoko itulon ilo Pacific Ocean jen Hawaii nan Alaska. Wewen in ealikar bwe enaj lab wot an jelet wod im men in mour ko einwot mejen-wod ak jukkwe (clams) im dri ko (mussels) im enaj aban aer drittak lok ak emaron bar jelet wewen ko jet.

Wewen kein rej kalikar bwe jabdewot kain jerbal in bobrae naaj aikuji nan kejbarok ecosystems eo nan kadriklok wewen ko rekauotata rejelete rainin.

5. BUNten KO ILO WODEN BWIL KEIN IM MAKITKIT IN JERBAL KO JEN LAL KO ILIKIN

Kein eo an RMI ejjab make ian ilo an jerbale wewen kein. 

1.2 BETELNUT

'Betelnut' refers to the fruit or nut of any variety of the palm 'Areca catechu'. Whilst betelnut may be imported for personal consumption, strict prohibitions in regard to its use, importation and distribution have been imposed. Any betelnut found in the possession of a minor will be presumed to be the property of that minor person and will be confiscated.

YOU MUST NOT

- ✗ Import for sale or distribute betelnut.

Penalty:

- for a first offender, up to 30 days imprisonment or \$100 fine or both; and
- for a repeat offender, up to 3 months imprisonment or \$300 fine or both.

KAKEMEMIJ:

If the occupant of a vehicle litters the driver has also committed an offense and both the occupant and driver can be penalised.

- ✗ Publicly be in possession of or use betelnut in any form if you are a minor.

Penalty:

- for a first offender up to 5 days community service or \$100 fine; and
- for repeated offender, up to 10 days community service or \$200 fine.

- ✗ Discharge betelnut spittle, substances or refuse in places accessible to the public.

Penalty:

- a fine not less than \$50 and or community service for one week.




Figure 1: Pija in ej kwalok ijo aiboj dren eo ej bed ilo iumin bwidej ion (exaggerated vertical scale)¹


